BUDGET HEARING: The Budget Hearing was declared opened. No testimony from patrons. Chris Panike took a few moments to explain the latest development from the Legislation on PERS. Chris built the budget based on PERS rates published late last year for the 2013-2015 biennium. Senate Bill 822 was recently signed by the Governor and it reduced the PERS rates that we have to pay for the 2013-2015 biennium by a total of 4.4%. this means we have budgeted our PERS expense at a higher levels than will actually occur. The reduction in forecast PERS expenditures will hopefully offset any reductions in revenue caused by student attendance at levels less than the original state estimate on which the budget was built. Mr. Panike then went on to explain that the budget was also based on a higher level of attendance than the current year attendance. If the forecast is wrong and student population decreases, we will have budget revenue decreased. With no further discussion, the Budget Hearing was closed at 7:20 p.m.
